The lawsuit involving the City of San Francisco and County of San Francisco was settled out of court with prejudice towards the city. This was the case regarding dispatcher immunity.

(From the Sacramento Bee 12/20/2003) Although the above case was settled out of court, the California Supreme Court recently ruled that government 9-1-1 emergency dispatch agencies cannot be sued, even if they fail to respond to calls for help. The seven justices, in settling conflicting lower court rulings, said that 9-1-1 operations are generally immune from lawsuits

DeAnn Pressley – Mercy Air, Mercy Air currently has 2 openings in their Omaha, Nebraska office. Mercy Air is no longer dispatching from it's Rialto location. The dispatch center was moved to Omaha, NE. If there are any service concerns or complaints, they can be directed to DeAnn at Mercy.

Don Wise – Verdugo Fire, Currently have two prospective new hires in background investigations. The backbone for the Motorola and MCT system has been installed. Monterey Park will be joining the consortium by July of 2004 and Alhambra after that. These two additions will make Verdugo Fire a true Area C dispatch facility with a total of 11 cities. Verdugo is also part of the FireNet Statewide system.

Brian Acosta – San Bernardino County Fire, Recently hired one full time dispatcher and two part-time dispatchers. San Bernardino has several operators out on Worker's Comp. Injuries.

Walt Moulton – Kern Co. Fire, currently testing 100 applicants for one open position. Should have the new VHF system up and running by the end of May 2004. Received a grant for new MDC's.

Robert Stoffel – Orange County Communications, reported that the City of La Habra is looking at contracting with L.A.County Fire. The Orange County Fire Authority is building a new complex in Irvine. This will also house a dispatch center. They are looking to move in within the next year.
