Gabby has been our treasurer for at least the last 4 years, if not longer. Due to this turn of events, Peggy Piscopo of Torrance Fire Department has agreed to assume the role of Treasurer. Round Table:

Don Wise – Verdugo Fire, Verdugo currently has one opening for a Lateral dispatcher. Will be upgrading their current PRC CAD system with the latest GUI version. Looking at Intergraph for the Radio interface. Walt Moulton – Kern Co. Fire, Kern Co. is in the middle of the VHF radio acceptance test. If all goes well, they will begin to cutover to it around the 15^{th} of November. Installing the newest version of Vesta and looking at replacing their console furniture around January or February.

Gary Bush – San Bernardino Co., Went to the Vesta Symposium in July with only a few bugs with the system differentiating between call takers, dispatchers and supervisors being logged on at the same time. Will be looking at new console furniture with in the next 6 months to a year.

Tim Maloney – CDF-South Ops, CDF is installing PRC Altaris CAD system statewide. They are only in Phase 1 of the install at the present moment. Upgrading to the new "ROSS" Resource Ordering and Staffing System by next May. MIRPS will be available in California for the next year.

Peggy Piscopo – Torrance Fire, Fire will be combining their dispatch center with the police departments dispatch center operating out of the police station. The move will take place around March or April. Essentially they will be running 2 different CAD systems with in the same dispatch center. Fire has just upgraded their Vesta system. Currently down 1 full-time position due to Lauren retiring after 35 years of service.

Gary Stevens – South Bay Comm., Currently have 4 new operators in training. Is currently working with the state for the replacement/upgrade of their current Vesta system to the newest version. Hoping to add positions and acquire MagIC.
