Location: Orange County Fire Authority

Training topics/discussions will include the Metrolink train derailment. LA Countys dirty bomb exercise review from back in Dec and a 45-60min presentation on stress and how it effects dispatchers.

Directions :

From: Kern/Ventura/LA

Take the 5 fwy SB to Jamboree, Irvine exit Jamboree and go north towards the mountains. You will pass Irvine Blvd and Portola Pkwy. Once you are passed Portola, the RFOTC will be on the right not to far up along the Toll Rd. You cannot miss it. Turn in the first gate which is 1 Fire Authority Way. Go around the circular area where the Firefighter memorial is and turn to the right and park along the back wall adjacent to the Toll Rd.

From the LA area, you can also take the 5 fwy to the 91 EB if you want to the Toll Rd. Take the Toll Rd to Chapman/Santiago exit. Turn right on Chapman/Santiago to Jamboree. Turn left on Jamboree to the RFOTC, enter at 1 Fire Authority Rd., the main gate, which is the second gate from this direction.

From: San Diego

Take the 5 fwy NB to Jamboree and the same

from there. unless you are more inland and you can take the 15 fwy NB, same as below for Riverside people off the 15 fwy.

From: Riverside

Take the 91 WB or the 15 NB to the 91 WB, then stay on the 91 fwy until you get to the 241 Toll Rd and take the Toll Rd. Stay on the Toll Rd and you can pay at the Windy Ridge Toll Plaza. Stay on the Toll Rd until you get to the Chapman/Santiago exit and exit. You will want to turn right on Chapman/Santiago until you come to Jamboree, which is the first intersection. Turn left and take Jamboree to the main entrance of the RFOTC, which is the second gate coming from this direction at 1 Fire Authority Rd. Follow the circular driveway around the FF memorial and park

along the back wall to the right.

From: San Bernardino

Take the 10 or the 60 fwy to the 15 fwy and go South on the 15 fwy to the 91 fwy WB to the 241 Toll Rd. or you can go to the 57 fwy SB to the 91 EB to the 55 fwy SB to the 5 fwy SB to Jamboree or keep going to the 241 Toll Rd and take it to Chapman/Santiago exit.

or off the 55 fwy, you can exit Chapman in Orange and go left and take Chapman all the way to Jamboree through Orange city and turn right on Jamboree to the RFOTC.

The TB is 830H2 and I believe it is in the 2005 edition.
